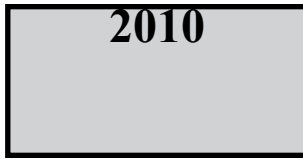

RELEASE, WAIVER OF LIABILITY, AND INDEMNITY AGREEMENT

I, the undersigned, do hereby for myself, my heirs, executors, and assigns, release, remise and forever discharge and agree to indemnify and hold harmless individuals, officers, agents, sponsors, co-sponsors, sanctioning bodies, servants, land owners, vehicle owners, lessees of premises used to conduct the event, employees, RMEC and RMEC Officers, all for the purposes therein referred to as "Releasees" from every claim, demand, action or right of action of whatsoever kind or nature and any cost, lost or expense in connection therewith arising from or any reason of, or on the occasion of any use by, of the Wannabe Racing, Inc., course or related facilities including any claims or demands for injury to, or death of any person or damage to, or destructions of , any property resulting from or claim to result from or arise out of accident or occurrence during or in connection with said use including specifically such as may arise out of or be claimed to arise out of negligence on the part of said Wannabe Racing, Inc.
